

Export requirements for base station communication equipment





Overview

What are US export requirements?

U.S. export requirements are generally outlined in 15 CFR, Commerce and Foreign Trade; 19 CFR, Customs Duties; and 22 CFR, Foreign Relations. Sections of these regulations are referenced in the following paragraphs. It is DoD policy that vigilance will be exercised in preventing the export of agricultural pests to foreign Host Nations (HN).

What is a base station used for?

Can be used for an export declaration. Base stations of apparatus for the transmission or reception of voice, images or other data; Examples: - Base stations for cellular network .

What is a guide to international acquisition and exportability practices?

Section 1-1. Purpose This Guide to International Acquisition and Exportability practices is intended to provide Program Managers (PMs) with information needed to thoughtfully organize, plan, and execute DoD international acquisition activities regardless of acquisition pathway, acquisition category, contracting model, or program type. Section 1-2.

Where can I find a list of export license requirements?

The list can be found by clicking “Regulations and Commerce Control List”. Of those exports and re-exports subject to the EAR, a small percentage requires the submission of a license application to the Department of Commerce. Most DoD shipments are exempt from Department of Commerce export license requirements.

What are the approval procedures for equipment authorization?

The Commission has two different approval procedures for equipment authorization – Certification and Supplier’s Declaration of Conformity (SDoC). The required procedure depends on the type of equipment being authorized



as specified in the applicable rule part.

Are DoD shipments exempt from export license requirements?

Most DoD shipments are exempt from Department of Commerce export license requirements. License requirements are dependent upon an item's technical characteristics, the destination, the end use, and the activities of the end user.
