Overview

Does public money help the energy sector in Peru?

A considerably larger amount of public money committed to supporting the economy and people of Peru through monetary and fiscal policies in response to the crisis may also benefit different elements of the energy sector. However, these values are not available from official legislation and statements and therefore are not included in the database.

Is Peru on the road to energy transition?

How much energy can Peru generate?

According to energy regulator Osinergmin, Peru has the potential to generate up to 70 GW from hydroelectric sources, 77 GW from wind, and about 3 GW from geothermal sources, as well as having very high solar irradiance (especially in the south of the country).

Are large subsidy-free renewable generation projects a positive signal?

Likewise, the appearance of large subsidy-free renewable generation projects is a positive signal. This started with a corporate power purchase agreement (PPA) signed in 2021 between Engie and Anglo American to supply up to 187 MW of renewable power to Anglo's new Quellaveco copper mine.
