Overview

How much VC funding did solar companies get in 2024?

Global VC and private equity funding in solar in 2024 came to \$4.5 billion. There were 14 VC funding deals of \$100 million or more in 2024; 87% went to Solar Downstream companies. CHART: Solar VC Funding 2010-2024.

Why are solar companies growing so fast?

Solar companies are experiencing a period of growth following incentives provided by the Inflation Reduction Act of 2022, which allows taxpayers to subtract 30% of the cost of solar power from their taxes through 2032. 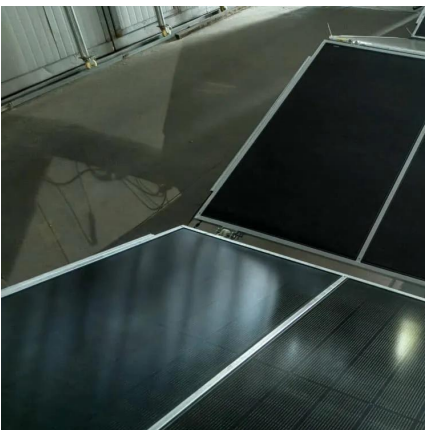
